To whom it may concern:

I would like the Ohio PUC to review my prior electric bills with the Illuminating Company with the hopes of a final bill reduction based on prior electric bills. I moved out of the above referenced apartment on May 31, 2021. I received my last bill dated June 10, 2021 in the amount of \$1,348.03. I immediately contacted the Illuminating company and was told that my last bill was an estimated bill and that because this is a final bill they were unable to come out and preform an actual read and they were unable to offer me a payment plan nor additional time to pay as this is a final bill.

I also received a letter dated June 10, 2021 stating that my bill was being estimated for the past seven months and based on the last actual reading the bill was for 12k kWh. I do not agree with the amount of kWh based on the amount of time I spent away from the apartment and when I was there the occupants consists of myself and a seven-year old boy. I immediately contacted the Ohio PUC and was given a case number and assigned an agent (Lee is his name) to the matter. On June 28, 2021 I followed up with my agent and was told I was allowed an extension until August 30, 2021 to pay the final bill but major matter of why the bill was being estimated or how they came up with that kWh was addressed nor did Lee sound concerned or interested. In my opinion, I strongly feel with estimating my bill the Illuminating company has taken advantage of me as a customer and to present me with a \$1,300.00 bill on June 10, 2021 with a due date of June 24, 2021 is not fair nor is it reasonable not knowing my financial situation. I attempted to obtain financial assistance from the following organizations (Step forward today.org, Catholic Charities and the Salvation Army) but to no avail they were either out of funds or there is a waiting list.

In addition to my request for the final bill reduction, I am asking for additional time to pay the final bill. I am the head of my household supporting one child and I have worked diligently to keep collection matters off my credit report and I do not wish to have this bill placed on my credit report.

Lastly, I have attached the final bill from the Illuminating company as well as the letter they sent me saying they were unable to contact me so that was their reason for estimating my bill for seven months when in fact that is not true. Not one time did the company make an attempt to let me know that they were not able to gain access to the area to read the meter as I was living in an apartment building!! And furthermore, if they were unable to gain access for seven months and were estimating how did they come up with an actual reading for the final bill??
