This letter serves as the Pre-Application Notification Letter to the Ohio Power Siting Board ("Board") of Wild Grains Solar, LLC's ("Applicant" or "Wild Grains") application for its proposed solar-powered electric facility.

In accordance with Ohio Administrative Code ("OAC") Rule 4906-3-03(A), Applicant provides the following information:

- **Project Description.** Wild Grains is proposing to develop, construct, and operate an up to 150 megawatt ("MWac") solar-powered electric generating facility in Hoaglin Township, Van Wert County, Ohio. Construction of the Project is anticipated to begin no earlier than the 3<sup>rd</sup> quarter of 2022, with commercial operation by December, 31 2023.
- **Pre-Application Public Informational Meeting.** Wild Grains has arranged for a public community meeting to be held on August 18, 2021 from 6:00 p.m. to 8:00 p.m. at Van Wert Fairgrounds located at 1055 South Washington Street, Van Wert, Ohio 45640. The meeting format will be similar to an open house. Maps of the project area will be available to review. Company representatives will also be available to answer questions.
