Co-Petitioners Norfolk Southern Railway Company (NSRC) and CSX Transportation, Inc.

(CSXT) respectfully move the Commission to order the Franklin Street crossings *temporarily* closed, pending the Commission's determination whether these crossings should be *permanently* closed.¹

¹ The prospect of this motion was broached via e-mail communications leading to and the pre-hearing conference of June 1, 2021. Since that date, by and through counsel, NSRC has followed with Orange Township in solicitation of the temporary closure of the Franklin Street crossings. By telephone on July 28, 2021, again by and through counsel, Orange Township confirmed that at this point the Township is not amenable to closing these crossings, temporarily or permanently, thus leading to the instant motion.

Temporary closure is warranted here, due to the involved equities, and more notably, since "it will enhance the safety of the traveling public".

MEMORANDUM IN SUPPORT

By way of history, the ORDC and NSRC/CSXT had identified the Franklin Street crossings as potentially viable closure candidates since, among other reasons, Franklin Street is a mere cut-through road which experiences a low volume of vehicular traffic, and has alternate access via adjacent crossings located less than 1/10th of a mile away); accordingly, these parties engaged in prolonged discussions with Orange Township – the local highway authority – to explore voluntary closure. These discussions ultimately proved fruitless, as Orange Township declined the ORDC/NSRC/CSXT's incentive offer in solicitation of voluntary closure. In light of same, NSRC and CSXT filed the instant petition seeking the permanent closure of these crossings. Following preliminary discovery (document production and depositions, etc.), the petition was scheduled for evidentiary hearing to be held on March 2, 2021. A month or so before the scheduled hearing, Orange Township approached NSRC/CSXT and asked whether the railroads (together with the ORDC) would be willing to re-commit to their pre-petition incentive offer;

assuming so, Orange Township represented that the offer would be accepted. NSRC/CSXT therefore revisited voluntary closure discussions with the ORDC, and ultimately secured the ORDC's authority to join the railroads in re-committing to the pre-petition incentive offer. At this point an agreement in principle was reached to close the Franklin Street crossings, and thus via Joint Request of February 18, 2021 the parties asked the Commission to continue the March 2, 2021 evidentiary hearing, with the hope/expectation that the hearing would not ultimately prove necessary. The Commission approved the Joint Request, but erred on the side of rescheduling the evidentiary hearing for June 1, 2021.

The settlement in principle was thereafter reduced to writing, with the ORDC re-issuing the incentive offer via letter of March 8, 2021, Orange Township "gladly accepting" the offer via letter of March 17, 2021, and Orange Township then passing a formal, confirmatory resolution on April 19, 2021 which stated in pertinent part as follows: "The Township finds the proposal to be in the best interest of the community in that it will enhance the safety of the traveling public." (Copies of these documents are attached.) In reliance thereon, the ORDC thereafter expended significant resources (personnel hours, etc.) toward securing requisite federal funding, and the parties then turned their attention to logistical closure. Unfortunately, on May 21, 2021, as closure logistics were being finalized, Orange Township did an unanticipated, absolute about-face, and passed a resolution purporting to rescind its earlier resolution agreeing to close the Franklin Street crossings. Orange Township's actions culminated in its counsel filing an immediate notice of withdrawal and, ultimately, in the Commission further continuing the evidentiary hearing through October 12, 2021, more than seven (7) months after it otherwise would have been held.

Under Ohio law (R.C. 4905, et seq.), the Commission claims plenary power to promote and enforce orders relating to the protection, welfare, and safety of both railroad employees and the traveling public. In the instant case, due to the involved equities, and more notably toward "enhancing the safety of the traveling public," the Commission should exercise this power to temporarily close the Franklin

Street crossings, pending the Commission's determination whether the crossings should be permanently closed.

As for the equities, Orange Township's actions – specifically, its request that ORDC/NSRC/CSXT re-commit to their pre-petition incentive offer, its informal and then formal acceptance of the incentive offer, and then its 11th hour attempt to rescind that acceptance – resulted in the evidentiary hearing being pushed back for over seven (7) months – from March 2, 2021 through the currently-scheduled date, October 12, 2021. As for safety, one of the involved crossings currently ranks #32 in the State, in the PUCO hazard rankings, and the Township's own resolution of April 19, 2021 confirms that closure would "enhance the safety of the traveling public".

For the foregoing reasons, the Commission is asked to exercise its plenary power by ordering the Franklin Street crossings temporarily closed, pending the Commission's determination whether the crossings should be permanently closed.

In May of 2013, September 2016 and August 2018, the Ohio Rail Development Commission (ORDC) provided proposals to Orange Township for the closure of the TR 1041, Franklin Street grade crossing (Norfolk Southern (NS) #481482D and CSX #518257V). Each of these proposals was rejected by Orange Township. Since that time, NS and CSX petitioned the Public Utilities Commission of Ohio (PUCO) to close Franklin Street. It is my understanding that NS, CSX, the Delaware County Board of Commissioners, Orange Township and the Delaware County Engineer have an agreement in principle to voluntarily close Franklin Street if Orange Township and ORDC can identify an eligible project for ORDC's funding.

Based on the most current information provided, ORDC proposes the following in consideration for the closure of Franklin Street:

- A \$25,000 cash incentive from NS to be used for any purpose deemed appropriate by Orange Township;
- A \$5,000 cash incentive from CSX to be used for any purpose deemed appropriate by Orange Township;
- A reimbursement of up to \$5,000 from ORDC to the Township to be used toward associated costs of permanently barricading the roadway at Franklin Street; and
- Depending on project viability and community input, to be determined jointly by ORDC and Orange Township as project details become known, <u>either</u> of the following alternatives:
 - ORDC will provide up to \$350,000 to Orange Township toward the proposed underpass for DEL-TR114 (East Orange Road DOT# 481481W), under CSX and NS:

RES.NO.21-140 ACCEPTING THE PROPOSAL OF THE OHIO RAIL DEVELOPMENT COMMISSION (ORDC), CSX TRANSPORTATION (CSX) AND NORFOLK SOUTHERN RAILWAY COMPANY (NS) FOR THE CLOSURE OF PUBLIC GRADE CROSSINGS ON FRANKLIN STREET, TR 1041.

The Board of Trustees of Orange Township, Delaware County, Ohio ("Board") met in regular open session on April 19, 2021.

Mr. Grumbles Moved the adoption of the following Resolution.

PREAMBLE

To provide consent for the permanent closure to vehicular and pedestrian traffic of a public grade crossing as recommended by the Ohio Rail Development Commission (ORDC), CSX Transportation (CSX) and Norfolk Southern Railway Company (NS).

WHEREAS, a proposal has been made to change the character of Franklin Street, TR 1041 by prohibiting through vehicular and pedestrian traffic over the at-grade, CSX and NS crossings thereby benefitting the safety of the traveling public; and,

WHEREAS, if vehicular and pedestrian traffic at the grade crossing is discontinued, Orange Township (Township), and ORDC have agreed to arrange for the accommodation, funding, and installation of improvements to the Township highway system; and,

WHEREAS, the Township agrees with the foregoing and desires to provide its consent to permit permanent closure of the aforementioned public grade crossing subject to the terms and conditions set forth herein; and

WHEREAS, the proposal has been submitted to the Township and the Township finds the proposal to be in the best interest of the community in that it will enhance the safety of the traveling public.

NOW THEREFORE, BE IT RESOLVED by the Board, at least a majority of its members concurring:

SECTION I

That the Board hereby authorizes and approves changing the character of Franklin Street, by barricading and prohibiting vehicular and pedestrian traffic across the at-grade railroad crossings traversing the street.

SECTION II

That the Board hereby accepts the following incentive offer of the ORDC, CSX and NS in exchange for the Township's permanent closure of the Franklin Street crossing:

• \$25,000 from NS that may be used by the Township for any purpose;

- \$5,000 from CSX that may be used by the Township for any purpose;
- Up to \$350,000 for pre-approved grade crossings safety improvements: either a proposed underpass for DEL-TR114 (East Orange Road DOT #481481W and #518256N) or upgrade of warning devices to four-quadrant gates at Lewis Center Road at-grade crossing (DOT# 481483K and #518258C); and
- Up to \$5,000 reimbursement to the Township from ORDC for the actual cost of barricades.

SECTION III

That Ms. Taranto ("Designee") is hereby authorized to execute any and all documents ("Documents") and to do all other things he/she deems necessary to effectuate the purposes of this Resolution, including entering into any contractual agreements with CSX, NS, and ORDC. The signature of the Designee on any such Documents shall be binding upon the Board as if the Documents had been signed by at least a majority of the Board's entire membership.

SECTION IV

All formal actions of this Board concerning and relating to the passage of this Resolution were adopted in an open meeting of this Board, and all deliberations of this Board and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including R.C. § 121.22.

This Resolution shall take effect immediately upon adoption.
