The Office of the Ohio Consumers' Counsel ("OCC") and Northeast Ohio Public Energy Council ("NOPEC") request the prehearing conference scheduled for 10:00 a.m. on August 2, 2021 be transcribed by a court reporter. The PUCO's website currently states, "No Court Reporter Required" for this prehearing conference.

These cases involving refunds for FirstEnergy's significantly excessive profits and its overcharges for energy efficiency are important for consumers. By our count, FirstEnergy owes consumers more than a half-billion dollars. PUCO cases—especially cases involving FirstEnergy given the H.B. 6 scandal—should have public transparency, and transparency should include transcripts.

Accordingly, for the benefit of parties and the public, OCC and NOPEC ask the PUCO to transcribe the August 2, 2021 prehearing conference.
