The addition of this definition to the Company's Sheet No. 59 GENERAL TERMS AND CONDITIONS APPLICABLE TO GAS SERVICE, Page 1 of 8 serves to address the new requirement of OAC Rule 4901:1-13-14(C) established in Case No. 19-1429-GA-ORD¹.
