Dear Ms. Troupe:

Pursuant to Ohio Adm.Code 4906-6-03(A), Harrison Power LLC (“Harrison Power”) files this pre-application notification letter and will be submitting a Construction Notice to construct, own, and operate a less than one-mile in length natural gas feed line to serve the proposed Harrison Power Plant (the “Generating Facility”) that is planned in the Village of Cadiz Industrial Park, Harrison County, Ohio.

The Generating Facility was approved by the OPSB in Case No. 17-1189-EL-BGN.¹ The original gas pipeline configuration was automatically approved by the OPSB, pursuant to Ohio Adm.Code 4906-6-10, in Case No. 18-0073-GA-BLN on April 20, 2018, and an updated version of the Project was automatically approved by the OPSB in Case No. 19-852-GA-BLN on May 20, 2019. Harrison Pipeline Company, LLC was the applicant in those cases but the new applicant for the Construction Notice in this proceeding will be Harrison Power LLC (which will construct, own and operate the pipeline instead of Harrison Pipeline Company, LLC).

The proposed pipeline is similar in most respects to the pipeline approved in the prior proceedings referenced above. Differences to the pipeline proposed in this matter reflect project refinements associated with constructability review, engineering design, and efforts to minimize environmental impacts. These refinements include rerouting of the project’s centerline to avoid potential safety issues associated with proximity to steep terrain and an adjacent existing 69 kilovolt overhead transmission line and adjustment of the pipeline’s maximum allowable operating pressure to match the pressure in the source gas pipeline.
