On behalf of Clearview Solar I, LLC (the Applicant), Environmental Design & Research, Landscape Architecture, Engineering, & Environmental Services, D.P.C. (EDR) has prepared this memorandum as an addendum to the Phase IB Archaeological Survey Report (2021) prepared by our subconsultant Gray & Pape, Inc., for the Clearview Solar Project in Champaign County, Ohio (the Project). At the request of the Applicant, EDR tested four new leased parcels and two new collection routes for the Project (approximately 217 acres) in locations that were not previously subject to Phase IB testing (see Figure 1). This field work was conducted by EDR between June 7th and 9th, 2021.

All archaeological services provided by EDR for the Project were conducted under the supervision of a Registered Professional Archaeologist who meets the Secretary of the Interior's Guidelines (per 36 CFR, Part 61) for Professional Qualifications in Archaeology. In addition, the work was conducted in accordance with applicable portions of the Ohio Historic Preservation Office (OHPO) Archaeology Guidelines (1994) and the methodology described in the Phase IA Cultural Resources Survey, Clearview Solar Project, Adams Township, Champaign County, Ohio (2020).

In total, EDR conducted Phase IB archaeological survey for approximately 217 acres of proposed solar arrays and 0.6 linear miles of buried electrical collection lines in six locations designated as Survey Areas 4 through 6 and 21 through 23 (see Figure 1). This survey effort resulted in an area of potential effect (APE) of approximately 195.4 acres of pedestrian survey within plowed agricultural fields (per the *Archaeology Guidelines*; see Figure 2: Photolog: Photos 1-6). One Native American isolated find (4-NAIF-01), described below, was recorded during the survey. No historic period archaeological sites, building and/or structural remains (approximately 50 to 200 years in age, or older) were identified within the APE.

#### **Isolated Find 4-NAIF-01**

EDR field personnel identified one complete biface within Survey Area 4. The artifact was identified on the surface in a plowed agricultural field and was designated as 4-NAIF-01<sup>1</sup> (see Figure 1, Sheet 2 and Figure 2: Photo 7). The biface measures 4.8 cm in length and is derived from a light gray chert. The biface is a Palmer type dating to the Early Archaic. EDR completed an additional shovel test (A01) near to the surface find to test for the presence of additional buried artifacts and/or archaeological deposits, neither of which were identified in the shovel test soils or profile. Shovel test A01 was recorded as having an Ap-horizon measuring approximately 21 centimeters in depth and composed of brown (10YR 4/3) silty clay loam, underlain by a yellowish brown (10YR 5/4) silty clay loam B-horizon. Excavation of STP A01 was terminated at a depth of 31 centimeters. As an isolated find site 4-NAIF-01 is not recommended as eligible for listing in the National Register of Historic Places as additional investigations are unlikely to retrieve significant archaeological data for addressing research questions focused on Native American precontact lifeways.

Based on the results of the additional testing completed on the collection lines, EDR recommends that no archaeological resources eligible for listing in the National Register of Historic Places will be adversely affected by the construction of the proposed facility in these newly tested areas. EDR does not recommend any additional archaeological investigation for the proposed project.


