

FACILITY DESCRIPTION

Union Ridge Solar, LLC is proposing to develop, construct, and operate the up to 108 MW Union Ridge Solar Project (Union Ridge), a solar-powered electric facility in Harrison Township, Licking County, Ohio. The general purpose of the project is to maximize energy production from solar resources in order to deliver clean, renewable electricity to the regional transmission system to serve the needs of electric utilities and their customers,

DATE, TIME, AND LOCATION OF PUBLIC HEARING

The public hearing for this case shall consist of two parts and will be held in person. Consistent with CDC Guidelines and the May 17, 2021 Ohio Department of Health Order, unless otherwise specified by the facility, individuals who are not fully vaccinated should continue to wear a face covering and socially distance. 1. A local public hearing, pursuant to R.C. 4906.08(C), at which the OPSB shall accept written or oral testimony from any person, commencing on Tuesday, August 31, 2021, at 6:00 p.m.

The local public hearing in this matter shall be held on Tuesday, August 31, 2021, at 6:00 p.m. at the Harrison Township Trustees Office, Road Garage, 6750 Outville Road, S.W., Pataskala, Ohio 43062. For those individuals interested in testifying at the in-person local public hearing, a sign-in sheet will be available at the facility and witnesses will be taken in the order in which they register to testify. If individuals wish to supplement their testimony with an exhibit for the OPSB's consideration, a copy of the document should be provided to the ALJ during the local public hearing. Testimony to be provided will be limited to five minutes in duration

2. An adjudicatory hearing, commencing on Tuesday, September 14, 2021, at 10:00 a.m.

The adjudicatory hearing shall commence on Tuesday, September 14, 2021, at 10:00 a.m. at the offices of the Public Utilities Commission of Ohio (PUCO), Hearing Room 11- C. 11th Floor. 180 East Broad Street. Columbus, Ohio 43215-3793. The parties should register at the lobby desk and then proceed to the 11th floor to participate in the hearing. Any accommodations necessary to ensure availability of social distancing and plexiglass dividers should be made in advance of the hearing. As pandemic restrictions are evolving, additional instructions regarding further safety requirements or accommodations for the hearing room will either be posted on the PUCO/OPSB website or communicated to the parties.

OPPORTUNITY TO COMMENT ON PROPOSED FACILITY

The public will be given an opportunity to comment on the proposed facility. As noted above the local public hearing will be held on Tuesday, August 31, 2021, in a session beginning at 6:00 p.m.
