COMPLAINT:--LACK OF TRANSPARENCY ON BILLING STATEMENT.

ON 07/14/2021, I CALLED THE ILLUMINATING COMPANY CUSTOMER SERVICE DEPARTMENT AFTER LOOKING AT MY ILLUMINATING BILL RECEIVED IN THE MAIL THAT DAY TO ASK SPECIFIC QUESTIONS ABOUT HOW THE "DISTRIBUTION RELATED COMPONENT" AND THE "COST RECOVERY CHARGES" WERE COMPUTED. BOTH OF THESE CHARGES MAKE UP THE MAJORITY OF THE BILLING AMOUNT THAT THE ILLUMINATING COMPANY CHARGES-(the July bill showed that 97% of the \$122.84 Illuminating charges were related to these two items). THE CUSTOMER SERVICE PERSON I SPOKE WITH COULD NOT TELL ME WHY THESE CHARGES CHANGED EACH MONTH OR HOW THEY WERE COMPUTED: SHE STATED "SHE DID NOT HAVE THAT INFORMATION AND I WOULD HAVE TO CONTACT PUCO."

MY BILL TOTAL FOR THE JUNE/JULY PERIOD AMOUNTED TO \$186.76. I WAS ABLE TO PINPOINT CHARGES FROM THE SUPPLIER, ENERGY HARBOR LLC, BY MULTIPLYING MY KILOWATTS USED TIMES THE SUPPLIER RATE CHARGE-1,606 X .039801= \$63.92....THAT PORTION WAS TRANSPARENT AND REFLECTED ON THE BILL-I KNOW WHAT I'M CHARGED FOR.

BUT THE DETAIL OR SUPPORT IS LACKING FOR THE ILLUMINATING CHARGES TITLED "Distribution Related Component" and the "Cost Recovery Charges". THEY ARE VERY SIGNIFICANT CHARGES ON MY UTILITY BILL THAT MAY HAVE BEEN APPROVED BY PUCO, BUT OHIO CONSUMERS WHO ARE PAYING THE BILL EACH MONTH HAVE A RIGHT TO KNOW WHAT THAT CHARGE IS MADE UP OF AND HOW IT WAS DETERMINED. IS IT BASED ON A FLAT RATE? IS IT COMPUTED BASED ON USAGE AND A FLAT RATE. WHAT ARE BEHIND THESE CHARGES? HOW ARE THESE CHARGES DETERMINED? THE SUPPLIERS ARE ABLE TO PROVIDE THEIR PORTION. THE ILLUMINATING CO. AND PUCO HAVE A RESPONSIBILITY TO ITS CONSUMER TO BE AS TRANSPARENT ABOUT ALL CHARGES ON THE BILL.

REQUEST/SOLUTION: CHANGE THE BILL SO OHIO CONSUMERS CAN UNDERSTAND CHARGES-ESPECIALLY THE VARIABLE COMPONENTS.

THE PUCO REP STATED THAT PUCO DETERMINED ADDITIONAL INFORMATION ON THE BILL WAS NOT NEEDED AND APPROVED THE BILLING STATEMENT AS IS. IF THIS IS TRUE, I BELIEVE PUCO FAILED OHIO CUSTOMERS BY NOT PROVIDING TRANPARENT BILLING AND SHOULD EXPLAIN AND CHANGE THEIR POSITION. DID THEY AT LEAST GET INPUT FROM THE CONSUMER? THERE IS PLENTY OF SPACE ON THE BILLING STATEMENT TO REFLECT THE CALCULATIONS FOR THESE TWO CHARGES. THE CONSUMER HAS A RIGHT TO KNOW THE VISIBLE SOURCE OF ALL CHARGES.
