Birch Solar I, LLC, a wholly-owned subsidiary of Lightsource bp, will host a third public informational meeting in person on Thursday, August 19, 2021 to outline plans to construct the Birch Solar Project, a solar-powered generation facility located in Shawnee Township, Allen County, Ohio, and Logan Township, Auglaize County, Ohio. The facility will be sited on approximately 1,410 acres and have a maximum total generating capacity of up to 300 megawatts. The purpose of the facility is to generate electricity to PJM. Construction is anticipated to begin as early as first quarter 2022, resulting in commercial operations in second quarter 2023. A map showing the general outline of the project area is below.




