OBJECTIONS TO STAFF REPORT OF THE OHIO ENERGY GROUP

Pursuant to R.C. 4909.19 and Ohio Admin. Code 4901-1-28, the Ohio Energy Group ("OEG") submits its Objections to the Staff Report filed on July 26, 2021, in the above-captioned proceedings.

1. OEG objects to Staff's proposal regarding the "Low Load Factor Provision" for Primary customers.1 The costs being recovered through base distribution rates are primarily demand driven and recovering these costs through demand charges is appropriate. A capped or modified rate for lower load factor customers is a subsidy as it transfers cost responsibility from lower load factor customers to higher load factor customers. OEG objects to Staff's proposal to the extent that it would preserve this subsidy in rates. OEG further objects to Staff's proposal on the basis that it has not provided a rate impact analysis in support of its position.

- 2. OEG objects to the Staff Report to the extent that it does not address whether the base rate freeze agreed to by Dayton Power and Light Company in its first Electric Security Plan ("ESP 1")² prevents AES from increasing rates for as long as ESP 1 remains in effect.
- 3. OEG objects to the amount of the increases/decreases in distribution rates outlined in the Staff Report for Primary, Primary Substation and High Voltage customers.³
