This letter serves as the Pre-Application Notification Letter to the Ohio Power Siting Board ("Board") of the Scioto Farms Solar Project, LLC's ("Applicant" or "Scioto Farms Solar") Application for a Proposed Solar-Powered Electric Generating Facility.

In accordance with Ohio Administrative Code ("OAC") Rule 4903-3-03(A), Applicant provides the following information.

Project Description

The proposed facility, the Scioto Farms Solar Project, LLC, is a solar-powered electric generating facility located in in Wayne Township, Pickaway County, Ohio. The facility will be sited on approximately 1,070 acres and have a maximum total generating capacity of up to 110 megawatts. The purpose of the facility is to generate electricity, and it is intended to fill the need for a more diverse national energy portfolio that will include a higher percentage of energy generated through the use of renewable resources. Construction is anticipated to begin as early as the fourth quarter of 2022, resulting in commercial operation in 2024.

Pre-application Public Informational Meeting

Scioto Farms Solar will hold an in-person public informational meeting on September 14, 2021 from 6:00pm to 8:00pm at the Hampton Inn, 1520 S. Court Street, Circleville, OH 43113. The meeting format will be similar to an open house and maps of the project area will be available to review. Company representatives will be available to answer questions. Those who attend the meeting may provide written comments that Applicant will summarize and include in its application.
