By its application, Christi Water System, Inc. (Christi) seeks a rate and charge increase under a new, consolidated rate structure. According to a Commission staff analysis, under the rates and terms proposed by Christi, a customer using 400 cubic feet (c.f.) of water would see a bill increase of approximately 70 percent. The current rates include base rates established in Case No. 09-569-WW-AIR and purchase water rate last updated in Case No. 15-423-WW-PWA, respectively.

The staff of the Commission recommends the proposed rate structure be rejected and recommends an increase over current revenue of 35.8 percent. Under the staff developed rates, a customer using 400 c.f. of water would see a bill increase of approximately 34.6 percent.

The major issues raised in this case are:

- (a) The rate structure and tariff language.
- (b) The determination of revenues and operating expenses.
