In the Matter of the Letter of Notification Application of Cadence Solar Energy LLC to Construct the Cadence Solar Energy Center Transmission Line.

Dear Ms. Troupe:

Pursuant to Rule 4906-6-03(A) of the Ohio Administrative Code ("O.A.C."), Cadence Solar Energy LLC ("Applicant") files this Preapplication Notification Letter with the Ohio Power Siting Board ("Board") regarding construction of an electric power transmission line of approximately 1.3 miles in length in Union County, Ohio. The transmission line will connect the Cadence Solar Energy Center, which is pending before the Board in Case No. 21-1677-EL-BGN, to American Electric Power's Marysville 345-kilovolt substation.

The Applicant anticipates commencing construction of the transmission line as early as the second quarter of 2023, with the Cadence Solar Energy Center being placed in service as early as the fourth quarter of 2023.

At this time, in accordance with O.A.C. Rule 4906-6-03(B), the Applicant notes that it will be requesting expedited processing. The Applicant will submit payment of the \$2,000 expedited processing fee in accordance with O.A.C. Rule 4906-6-04(A)(2) on the date of filing.
