Subject: Rate Case #20-585-EL-AIR

Description: I am very concerned about the proposed AEP dramatic increase in proposed charges for our school district and in particular the taxpayers within the Delaware City School District. This proposed increase is far in excess of what we would normally have budgeted for and would have a dramatic impact on the district's utility costs and require monies to be shifted from other essential areas. Our taxpayers are already paying in excess of the 1.0 index rate and this would potentially require us to come to the taxpayers sooner than anticipated for increased operating money further disproportionately affecting them.

Is this increase really warranted?

We have been taking advantage of energy saving modifications to existing and new facilities whenever fiscally responsible and doing our share. We want to be a good partner.
