**STATUS REPORT OF SETTLEMENT DISCUSSIONS**

---

The August 9, 2021 Entry ordered that Ohio Edison Company, The Cleveland Electric Illuminating Company and The Toledo Edison Company (“the Companies”) file correspondence providing the status of settlement discussions every 30 days. That update should provide “the

status of settlement negotiations, including the number of settlement meetings that have occurred in which all parties were invited to participate.”<sup>1</sup>

Settlement discussions continued from August into September and are ongoing. In the month of September, settlement meetings in which all parties were invited to participate took place on September 17, 27, and 29. In addition, throughout the month, the Companies and other parties engaged in further communications regarding settlement.

This may not be an exhaustive list of all settlement negotiation activity in September and there may have been other negotiation activity in which the Companies were not involved.
