## **EXHIBIT A**

### **Description of Services**

#### **1. Service Provision Method**

Applicant, CenturyTel Broadband Services, LLC (“CTBS”), plans to provide resold and facilities-based services.

#### **2. Description of Proposed Services**

CTBS seeks statewide authority as non-BLES competitive local exchange carrier (“CLEC”) and an intrastate interexchange carrier (“IXC”). Initially, CTBS plans to operate as a reseller and will enter into any necessary agreement(s) for this purpose. Ultimately, CTBS may build a network in areas outside the territory of its Ohio ILEC affiliates, and therefore, is requesting reseller and facilities-based authorization.

#### **3. Description of the general geographic area served**

CTBS seeks statewide authority, but will initially offer service in the local exchanges served by of CenturyTel of Ohio, Inc. d/b/a CenturyLink, United Telephone Company of Ohio d/b/a CenturyLink, and United Telephone Company of Indiana, Inc. d/b/a CenturyLink, as detailed in Exhibit F-2. CTBS will notify the Commission through the Telecommunications Filing Form if it expands its service operation area.

#### **5. Explanation of how the proposed services in the proposed market area are in the public interest**

CTBS will provide alternative local exchange and intrastate interexchange services, increasing customer choice and competition within the state of Ohio. Increased competition in telecommunications services has long been recognized by state and Federal regulatory authorities as being in the public interest by maintaining lower prices and increasing the diversity of service offerings for the public’s benefit. Introduction of competition into telecommunications markets, such as local exchange service, long distance, competitive access, and customer premise equipment, has lead to public interest benefits, including innovative products and competitive rates, in those markets.

CTBS’s proposed services will provide multiple public benefits by increasing the efficiency of incumbents by providing users of telecommunications service with greater reliability, and by increasing the competitive choices available to users in the state. Enhanced competition in telecommunications services likely will further stimulate economic development in Ohio. In addition, increased competition will create incentives for lower prices, more innovative services, and more responsible customer service.

#### **6. Description of the class of customers (e.g., residence, business) that the applicant intends to serve**

CTBS will provide services to residential, small business and enterprise customers.

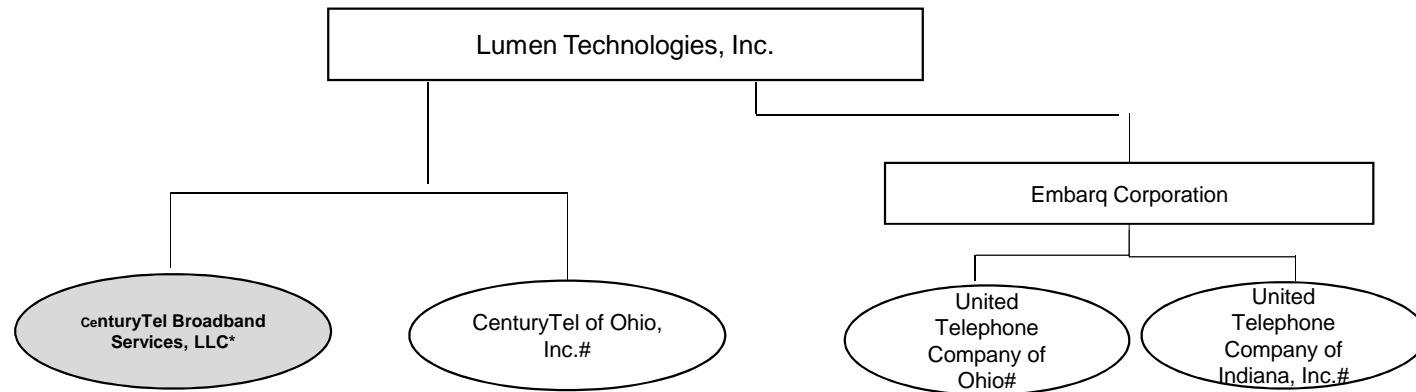

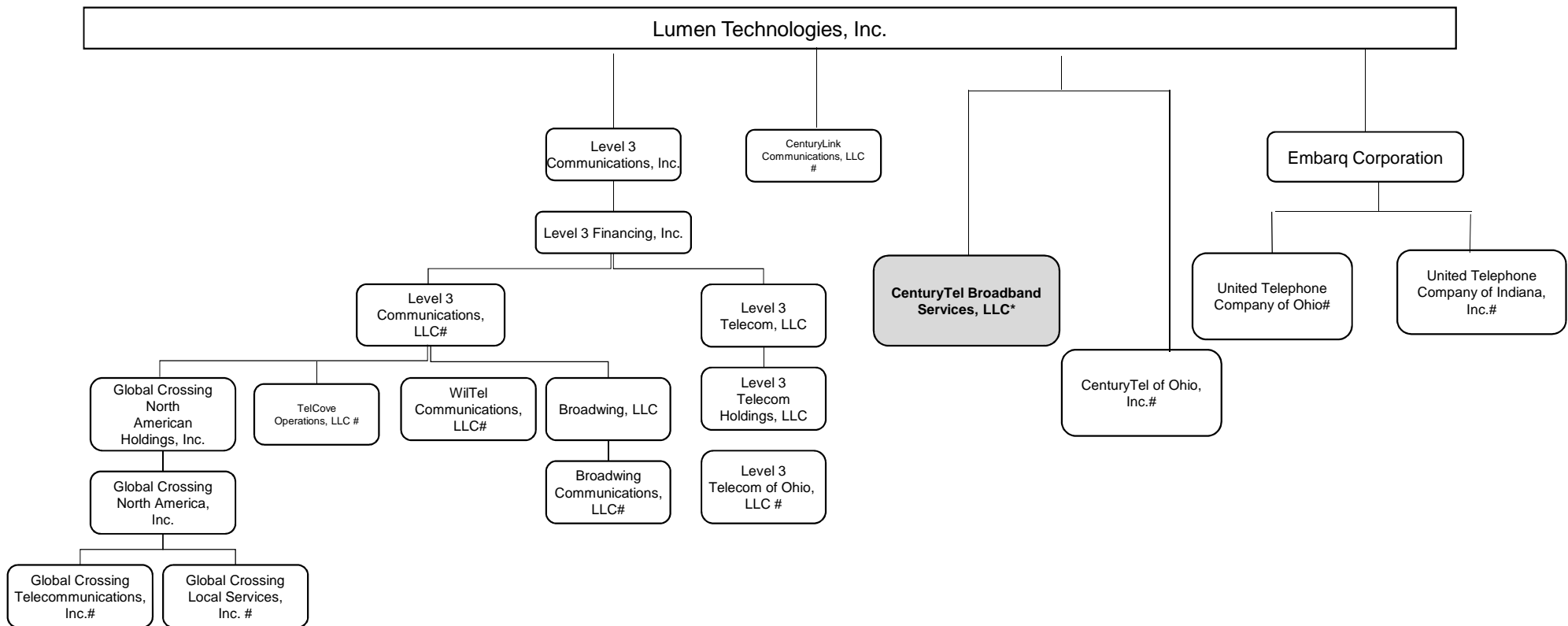
