Terracon wanted to contact you to make you aware of an update to the Fox Squirrel Solar Farm boundaries. An exhibit showing the the addition has been included with this email for your convenience.

You had provided concurrence on December 14, 2020 (EVENT# 03E15000-2021-E-00645) recommending that seasonal clearing be conducted to prevent the take of any listed bat species. The concurrence letter is attached. The additional parcels consist of row agricultural land and no additional clearing is proposed to be conducted. No wetlands or other jurisdictional waters are proposed to be impacted as part of the addition. As no additional potentially suitable habitat would be disturbed, Terracon believes no further action is required. We are providing this update to make you aware of the increase in acreage to the proposed solar farm.
