## **Notice of Proposed Major Utility Facility**

Tymochtee Solar, LLC (Tymochtee Solar), an indirectly owned subsidiary of Apex Clean Energy Holdings, LLC, is proposing to construct a solar-powered electric generation facility of up to 120 megawatts located in Tymochtee and Sycamore Townships, Wyandot County, Ohio. The facility will be sited on approximately 800 acres. The general purpose of the Facility is to maximize energy production from solar resources in order to deliver clean, renewable electricity to the Ohio bulk power transmission system to serve the needs of electric utilities and their customers.

Tymochtee Solar filed its application with the Ohio Power Siting Board (OPSB) for a certificate to construct, operate, and maintain the proposed facility in OPSB Case No. 21-4-EL-BGN. A copy of the application is available on the OPSB website at http://dis.puc.state.oh.us/CaseRecord.aspx?CaseNo=21-0004-EL-BGN and Tymochtee Solar's website at: https://www.tymochteesolar.com. The application is currently pending.

On August 17, 2021, the OPSB established the procedural schedule in this case. The public will be given an opportunity to comment on the proposed facility. The first notice of the procedural schedule was published in *The Daily Chief – Union*, a newspaper of general circulation in the project area, on August 21, 2021.


The public hearing in Tymochtee Solar's OPSB case shall consist of two parts and will be conducted in person:

- (1) A local public hearing, pursuant to R.C. 4906.08(C), where the Board shall accept written and oral testimony from members of the public who are not parties to the case on October 26, 2021, in a session beginning at 6:00 p.m., Wyandot County Fair, Master's Building, 10171 OH-53, Upper Sandusky, Ohio 43351.
- An evidentiary hearing to commence on November 16, 2021, at 10:00 a.m., 11th floor, Hearing Room C, at the offices of the Public Utilities Commission of Ohio, 180 East Broad Street, Columbus, Ohio 43215- 3793. The purpose of the evidentiary hearing is for Tymochtee Solar, Staff, and intervenors to provide evidence regarding the Project.

Consistent with CDC Guidelines and the May 17, 2021 Ohio Department of Health Order, unless otherwise specified by the facility, individuals who are not fully vaccinated should continue to wear a face covering and socially distance.
