12			degree in Environmental Design from the University at Buffalo in 1991,
13			and a Masters of City and Regional Planning degree from The Ohio State
14			University in 1993.

16			I have been employed at the Commission for roughly twenty years. My
17			responsibilities at the Commission have primarily involved social and
18			cultural resource matters associated with site planning of major utility
19			facilities in the state of Ohio. I have also been the Staff project lead on
20			numerous applications for a Certificate of Environmental Compatibility and
21			Public Need before the Board. Additionally, I have over ten years of
22			experience in public and private sector development and planning.

The Applicant proposes to develop, construct, and operate a 100 MW solar-14 A. 15 powered electric facility to be located in Marion County, Ohio.

17 7. Q. Please summarize Staff's investigation that was conducted in this case.

A. Staff's investigation included reviewing the application, conducting site 19 visits to the proposed facility location, acquiring additional information 20 from the Applicant, obtaining input from state agencies that compose the Board along with other relevant state and federal agencies, and preparing a Staff Report of Investigation that presents Staff's analysis, conclusions, and recommendations. As a result of Staff's investigation, Staff recommends
that the Board approve the application, subject to the 32 conditions that are
presented in the Stipulation.

- 5 8. Q. What impacts did Staff review for the project in arriving at this conclusion?
- A. Staff reviewed various types of land use impacts including residential,
 recreational, institutional, ecological, cultural resources, agricultural, and
 overall geological suitability. Staff also reviewed the financial, noise,
