

3. To the best of my knowledge, information, and belief, the information and materials contained in the above-referenced Construction are true and accurate.

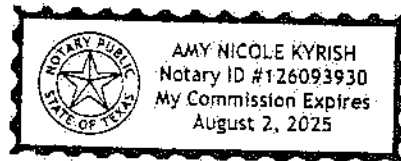
