EXHIBIT C- DESCRIPTION OF CHANGE

Cincinnati Bell Telephone Company, LLC (CBT) is increasing the price for BLES residential access lines effective December 1, 2021. CBT began providing notice of these increases via bill messages, beginning with bills issued November 1, 2021. Customers will also receive a second message on the subsequent bill stating that the residence access line increased by \$2.00 through January 1, 2022.
