Pursuant to Ohio Adm. Code 4901-1-21(B), please take notice that Interstate Gas Supply, Inc. ("IGS Energy") will take the depositions upon oral examination of Amy B. Spiller and Sarah E. Lawler for whom testimony is filed in the above captioned proceedings on behalf of Duke Energy Ohio, Inc. ("Duke").

IGS Energy proposes to conduct the deposition of Ms. Spiller at 10:00AM on Thursday, November 11th, 2021, or at a date and time mutually agreeable by the parties. The deposition will continue from day to day, except for holidays and weekends, until completed. The deposition of Ms. Lawler will commence at 10:00AM on Monday,

November 15, 2021, or at a date and time mutually agreeable by the parties. The deposition of Ms. Lawler will also continue from day to day, except for holidays and weekends, until completed. The deposition will be taken of the aforementioned deponents on relevant topics within the scope of the proceeding, including but not limited to, the subject matter of the deponent's testimony and the deponent's knowledge and expertise with the subject matter of these proceedings. The depositions will be taken upon oral examination (as upon cross-examination) before an officer authorized by law to take depositions.

Pursuant to Ohio Adm. Code Rules 4901-1-21(E) and 4901-1-20, each deponent is requested to produce, at least two hours prior to the taking of his or her deposition, all documents relating to the deponent's responsibilities with respect to the above-captioned proceedings and responses to discovery that were authored by the deponent or were provided to IGS Energy with input from the deponent. Additionally, the deponent shall bring documents, including, but not limited to, the results of any studies done for these proceedings and any backup documents, including raw data for such studies, any documents relied upon or cited in the pre-filed testimony, and any workpapers that support the pre-filed testimony.
