MEMORANDUM IN SUPPORT

Staff requests that the Commission keep both the Report of the Commission's Consultant Regarding AEP Ohio's November 2021 Standard Service Offer Auction and the Notification of Auction Results under AEP Ohio's CBP confidential and that they not be publicly released.
