Pursuant to Ohio Adm. Code 4901-1-21(B), please take notice that Duke Energy Ohio, Inc. (Duke Energy Ohio) will take the deposition(s) upon oral examination of any and all witnesses who file testimony on behalf of Retail Energy Supply Association (“RESA”) in opposition to the stipulation. Per the Attorney Examiner’s most recent Entry, such testimony must be filed by

intervenors by 12:00 p.m. on November 12, 2021.<sup>1</sup> Each witness will be called sequentially until the depositions are complete.

Duke Energy Ohio will conduct these depositions beginning at 8:30 AM on Tuesday, November 16, 2021. The deposition(s) will continue from day to day until completed. The deposition(s) will occur via video conference. Prior to the deposition, Duke Energy Ohio will provide instructions to the parties on how to participate.

The deposition(s) will be taken of the aforementioned deponent(s) on relevant topics within the scope of the proceeding, including but not limited to, the subject matter of the deponent's testimony and the deponent's knowledge and expertise with the subject matter of those proceedings. The depositions will be taken upon oral examination (as upon cross-examination) before an officer authorized by law to take depositions.

Pursuant to Ohio Adm. Code Rules 4901-1-21(E) and 4901-1-20, each deponent is requested to produce, at least two hours prior to the taking of his or her deposition, all documents relating to the deponent's responsibilities with respect to the above-captioned proceedings and responses to discovery that were authored by the deponent or were provided to Duke Energy Ohio with input from the deponent. Additionally, the deponent shall bring documents, including, but not limited to, the results of any studies done for these proceedings and any backup documents, including raw data for such studies, any documents relied upon or cited in the pre-filed testimony, and any workpapers that support the pre-filed testimony.
