

Notice of Application Regarding Major Utility Facility

On June 24, 2021, the Ohio Power Siting Board (OPSB) issued a Certificate to Firelands Wind, LLC (Firelands) an indirectly owned subsidiary of Apex Clean Energy Holdings, LLC (Apex) for the construction, operation and maintenance of a wind-powered electric generation facility of up to 297.66 megawatts in Erie and Huron Counties, Ohio, in OPSB Case No. 18-1607-EL-BGN (Facility). The purpose of the project is to produce wind-powered electricity that will maximize energy production from project area wind resources in order to deliver clean, renewable electricity to the Ohio bulk power transmission system to serve the needs of electric utilities and their customers.

On October 28, 2021, Firelands filed an application with the OPSB (Case No. 21-1055-EL-BGA) proposing an amendment/modification to the Certificate issued in OPSB Case No. 18-1607-EL-BGN to make minor revisions to the Certificate including updating information for four turbine locations, updating turbine manufacturing information, minor revisions to seven turbine locations, and two slight boundary changes to accommodate two sections of underground collection lines.
