## **ENTRY**

Entered in the Journal on November 19, 2021

- **{¶ 1}** Pursuant to R.C. 4905.26, the Commission has authority to consider written complaints filed against a public utility by any person or corporation regarding any rate, service, regulation, or practice relating to any service furnished by the public utility that is in any respect unjust, unreasonable, insufficient, or unjustly discriminatory.
- {¶ 2} The Dayton Power and Light Company d/b/a AES Ohio (AES Ohio) is a public utility as defined in R.C. 4905.02. Accordingly, AES Ohio is subject to the Commission's jurisdiction.
- {¶ 3} On September 9, 2021, Frederick and Danielle Sallee (Complainant) initiated a complaint against AES Ohio alleging, essentially, unjust and unreasonable billing practices.
- {¶ 4} Pursuant to Ohio Adm.Code 4901-9-01(B), a copy of the complaint was mailed to AES Ohio on September 9, 2021, directing AES Ohio to file its answer and any other responsive pleading within 20 days after September 9, 2021.
- {¶ 5} A review of the Commission's records reveals that AES Ohio has not filed any responsive pleading as required by Ohio Adm.Code 4901-9-01(B).
- {¶ 6} AES Ohio is ordered to file its answer and any other responsive pleading in this matter no later than December 9, 2021.
