Pursuant to Ohio Adm.Code 4906-3-03(A), Chipmunk Solar LLC (“Chipmunk Solar” or the “Applicant”), a subsidiary of EDF Renewables, files this Pre-Application Notification Letter regarding its proposed up to 400 MW solar powered electric generating facility within Deer Creek, Jackson, and Monroe Townships, in Pickaway County, Ohio (the “Chipmunk Solar Project”) with the Ohio Power Siting Board (the “Board”).

The location of the proposed Chipmunk Solar Project is being evaluated within approximately 3,680 acres of land in Pickaway County, Ohio. The purpose of the Chipmunk Solar Project will be to maximize energy production from solar resources to deliver clean, renewable electricity to the regional transmission system to serve the needs of electric utilities and their customers. Construction of the facility is scheduled to commence as early as the Second quarter 2023. The Chipmunk Solar Project is scheduled to be in service by the fourth quarter of 2024.

Chipmunk Solar is holding a public information meeting on Tuesday, December 7, 2021, at the Deer Creek Lodge, 22300 State Park Road 20, Mt. Sterling, Ohio 43143 from 6:00 – 8:00 p.m. Chipmunk Solar is also holding a virtual open house on Wednesday, December 1, 2021 from 6:00 – 7:30pm.
