### MEMORANDUM IN SUPPORT OF MOTION OF THE DAYTON POWER AND LIGHT COMPANY D/B/A AES OHIO FOR A CONTINUANCE TO OPPOSE THE APPLICATION FOR <u>REHEARING BY OFFICE OF THE OHIO CONSUMERS' COUNSEL</u>

The Office of the Ohio Consumers' Counsel ("OCC") filed a motion to dismiss the application of The Dayton Power and Light Company d/b/a AES Ohio ("AES Ohio" or the "Company") for a rate increase in August 2021.
