Dear Secretary Troupe:

In accordance with the December 18, 2019 Opinion and Order in the above-captioned proceeding, Ohio Gas Company ("Ohio Gas" or "Company") hereby submits its final reconciliation of the amortization of the Geographic Information System ("GIS") deferral through the GIS Rider authorized in this proceeding. The final reconciliation rate is a credit amount and is set at (\$0.43). This rate will be in effect for the January 2022 billing cycle, after which the rate will be set at \$0.00.

The 24-month amortization period for the GIS Rider will conclude December 31, 2021, before the final one-month reconciliation in January 2022. Application at  $\P$  6; Exhibit A page 3 of 4. The Commission-approved reconciliation procedure provides that the Company's proposed one-month reconciliation rate "will be deemed automatically approved on the thirty-first day after filing, unless the Commission takes action to suspend the automatic approval process . . . ." Application at  $\P$  7.

Attached is the final GIS Rider tariff sheet, which will become effective January 1, 2022. Also attached are a redline version of the tariff sheet, as well as supporting schedules. Please do not hesitate to contact me with any questions.
