The stipulation 19 incorporates many of the Staff Report 20 conditions. It represents that the facility 21 would be the minimum adverse environmental 22 impact considering the state of available technology and the nature of the economics of 23 24 various alternatives. 25 The facility would benefit

18 the public interests and represents and 1 2 addresses the issues that were raised at the local public hearing. 3 So the Stipulation and 4 Ο. 5 Recommendation accepts the Staff's findings, conclusion and recommendations as contained in 6 Staff Exhibits 1 and 2; is that correct? 7 8 Α. Yes. 9 MS. KERN: Thank you, your Honor. 10 I have no further questions for Mr. Conway and I 11 would respectfully move for the admission of 12 Staff Exhibits 1 and 2 subject to cross. 13 ADMINISTRATIVE LAW JUDGE SEE: Any 14 cross-examination for this witness, Ms. Milam? 15 MS.
