Exhibit C

Sprint Communications Company, L.P. was first certified to provide local exchange services and competitive telecommunications services in Ohio in *In the Matter of the Application of Sprint Communications Company, L.P. for a Certificate of Public Convenience and Necessity to Provide Local Telecommunications Services in Ohio*, Case No. 96-879-TP-ACE, Finding and Order (June 16, 1999). The Commission issued it certificate number 90-9015. Its tariff was filed in Case No. 90-9015-TP-TRF.

The certificate was amended after its July 21, 2004 and its August 17, 2006 applications were automatically approved in *In the Matter of the Application of Sprint Communications Company, L.P. to Amend its Certificate*, Case No. 04-1153-TP-AAC. Sprint Communications Company, L.P. has since been certified to provide local exchange services and interexchange services in Ohio.

Sprint Communications Company, L.P. is no longer serving any customers in Ohio with local exchange services or interexchange services that are subject to the Commission's regulation. It also no longer uses facilities in Ohio for the provisions of those regulated telecommunications services - it recently disconnected its final time-division multiplexing circuit in Ohio. Sprint Communications Company, L.P., therefore, proposes to abandon the telecommunications services it provides under its certificate, including its tariffs – P.U.C.O. Nos. 2 and 3 – in their entirety, and relinquish its certification.

Sprint Communications Company, L.P. will continue to provide VoIP-enabled services in Ohio. The provision of those services, however, does not constitute public utility service subject to the Commission's regulation or certification pursuant to Ohio Revised Code Sections 4905.02(A) and 4927.03(A).

Sprint Communications Company, L.P., has no retail or wholesale customers and does not provide services to any telephone company wholesale provider. As such, no notice of the proposed abandonment was provided pursuant to Ohio Administrative Code Rule 4901:1-6-26.

Sprint Communications Company, L.P., respectfully requests that this abandonment application be automatically approved, effective on the 31st day after filing.
