Dear Ms. Troupe:

AEP Ohio Transmission Company, Inc. (the “Company”) files this pre-application notification letter for the above-reference Project pursuant to Rule 4906-6-03(A) of the Ohio Administrative Code.

The Company is proposing to construct the Windsor Extension 138-kilovolt (“kV”) Transmission Line Adjustment Project (the “Project”) located in Warren Township, Jefferson County, Ohio. The Project involves adjusting the entire, approximately 0.4-mile approved Windsor Extension (OH) 138 kV Transmission Line Project (Case No. 21-0173-EL-BLN). The adjustment is required due to steep terrain and constructability concerns with the previously approved alignment.

The Company anticipates that construction of the Project will begin in February 2022. The anticipated in-service date for the Project is November 2022.

Pursuant to Ohio Adm. Code 4906-6-04, the Company requests expedited treatment of its application for this Project. Consistent with Ohio Adm. Code 4906-6-04(A), a copy of the Company’s application will be submitted to the executive director or the executive director’s designee at or before the application’s filing. A copy will also be provided to the Board Staff via electronic message. The Company will also submit a check in the amount of \$2,000 to the Treasurer, State of Ohio, for Fund 5610 for the expedited fees.
