Williams also filed on 8 9 November 3, 2021, and I believe that's OCC Exhibit 1. 10 And, your Honor, that covers the exhibits 11 that we wanted to move into evidence in support of 12 the Stipulation, and on that basis I would ask that 13 all those exhibits be admitted. 14 EXAMINER PARROT: Okay.
