PETITION FOR REVIEW OF THE PENNSYLVANIA PUBLIC UTILITY COMMISSION AND PUBLIC UTILITIES COMMISSION OF OHIO

Pursuant to Sections 205(g) and 313(b) of the Federal Power Act, 16 U.S.C. §§ 824*d*(g), 825*l*(b), Rule 15 of the Federal Rules of Appellate Procedure, and Rule 15 of the Third Circuit Local Appellate Rules, the Pennsylvania Public Utility Commission and the Public Utilities Commission of Ohio ("Joint Commissions") hereby petition this Court for review of the inaction of the Federal Energy Regulatory Commission ("FERC") that allowed proposed tariff changes to take effect, as memorialized by:

PJM Interconnection L.L.C., Notice of Filing Taking Effect by Operation of Law, Docket No. ER21-2582 (September 29, 2021).

The Notice is herein provided as "Attachment A".

On July 30, 2021, under Section 205 of the Federal Power Act ("FPA"), 16 U.S.C. § 824*d*, PJM Interconnection, L.L.C. ("PJM") filed tariff modifications concerning its Minimum Offer Price Rule, a rule setting offer prices in the regional electric wholesale capacity market that PJM oversees. The Joint Commissions timely protested the proposed tariff changes on August 20, 2021. Section 205(d) of the FPA provides FERC with a 60-day period to act upon rates filed by a public utility. 16 U.S.C. § 824*d*(d). FERC failed to issue an order accepting or denying PJM's filing within 60 days because the Commissioners were divided two against two as to the lawfulness of the change. Therefore, the proposed tariff changes went into effect by operation of law. 16 U.S.C. § 824*d*. Under these circumstances, FERC's failure to issue an order is treated as an order accepting the change for the purposes of rehearing. 16 U.S.C. § 824*d*(g)(1).

The Joint Commissions filed, on October 28, 2021, a timely request for rehearing of FERC's failure to issue an order accepting or denying PJM's proposed tariff changes. Section 205(g)(2) of the FPA provides that if FERC fails to act on the merits of a rehearing request within 30 days after it is filed, the aggrieved party may file an appeal. 16 U.S.C. § 824d(g)(2). FERC memorialized its failure to act on the rehearing request through a Notice of Denial of Rehearing by Operation of Law on November 29, 2021. Therefore, the Joint Commissions may seek judicial

review. 16 U.S.C. § 824*d*(g)(2) and 825*l*(b). The Notice of Denial of Rehearing by Operation of Law is herein provided as "Attachment B".

The failure of FERC to issue an order with respect to the proposed tariff changes adversely affects the Joint Commissions. The proposed tariff changes include provisions that would allow for the unchecked exercise of buyer-side market power in PJM's regional electric wholesale capacity market, compromising that market's competitive structure, prices, and the crucial element of reliability. The Joint Commissions are tasked with protecting consumers from market deficiencies and ensuring that electric markets provide safe, reliable electric service in a non-discriminatory, competitive manner. *See* 66 Pa.C.S. §§ 2801-2815 and Ohio Revised Code § 4928.02.

This Petition for Review is appropriately filed in the Court of Appeals for the Third Circuit. The Joint Commissions are aggrieved by the order of the Commission. Under 16 U.S.C. § 825*l*(b), parties aggrieved by an order of the Commission may obtain review in any Court of Appeals in which the public utility to which the order relates is located or has its principal place of business. PJM is the public utility to which the order relates. PJM operates and has its principal place of business in Pennsylvania.

This matter is ripe for appeal. The Commission's deemed acceptance of the PJM filing should be set aside.

NOTICE OF DENIAL OF REHEARING BY OPERATION OF LAW

(November 29, 2021)

On September 29, 2021, the Secretary of the Commission issued a Notice of Filing Taking Effect by Operation of Law in this proceeding for PJM Interconnection, L.L.C.'s (PJM) proposed revisions to its Open Access Transmission Tariff, filed pursuant to section 205 of the Federal Power Act. 16 U.S.C. § 824d. As explained in that Notice, in the absence of Commission action on or before September 28, 2021, PJM's proposal became effective by operation of law on September 29, 2021. The Commission did not act on PJM's filing because the Commissioners were divided two against two as to the lawfulness of the change.

Section 205(g) of the Federal Power Act provides that, in such circumstances, a party may seek rehearing of the Commission's "failure to issue an order accepting or denying" the proposed tariff revisions. 16 U.S.C. § 824d(g)(1)(A). Rehearing has been requested in this proceeding.

In the absence of Commission action on the requests for rehearing within 30 days from the date the requests were filed, the requests for rehearing may be deemed to have been denied. 16 U.S.C. § 825*l*(a); 18 C.F.R. § 385.713(f) (2020); *Allegheny Def. Project v. FERC*, 964 F.3d 1 (D.C. Cir. 2020) (en banc).
