
NOTICE OF PROPOSED MAJOR UTILITY FACILITY

On March 18, 2021, the Ohio Power Siting Board ("OPSB") issued a certificate to Big Plain Solar, LLC in Case No. 19-1823-EL-BGN for the construction, operation, and maintenance of the Madison Solar Farm (the "Project"). The Project is an approximately 196-megawatt solar electric generating facility in Oak Run and Fairfield Townships in Madison County, Ohio. The general purpose of the Project is to maximize energy production from available solar resources in order to deliver clean, renewable electricity to the Ohio bulk power transmission system to serve the needs of electric utilities and their customers.

On November 24, 2021, Big Plain Solar, LLC filed a first amendment application with the OPSB to add an O&M building, an additional 0.45-mile access road, and a new type of fencing (wildlife fencing), all of which will be located within the Project Area approved in the Case No. 19-1823-EL-BGN. Other aspects of the original application remain unchanged.
