**MEMORANDUM IN SUPPORT OF
MOTION FOR LEAVE TO AMEND
ANNUAL REPORT FOR CALENDAR YEAR 2020**

Choose Energy Inc. (“Choose Energy”) is authorized to provide competitive retail natural gas services in Ohio, under Certificate No. 13-331G, which was issued in Case No. 13-2092-GA-AGG. Choose Energy was authorized to provide competitive retail electric services under Certificate No. 12-588E, which was issued in Case No. 12-2696-EL-AGG. That certificate was canceled on July 19, 2021.

Choose Energy submitted its Annual Report for Fiscal Assessment for calendar year 2020 related to its Certificate No. 12-588E through the PUCO Community. It was discovered recently, following receipt of the assessment invoices, that Choose Energy’s Annual Report related to its Certificate No. 12-588E contained an error that resulted in an overstatement of Ohio electric sales volumes in 2020. Through this motion, Choose Energy requests leave to amend its 2020 Annual Report related to its Certificate No. 12-588E to correctly report its Ohio electric sales volumes for 2020. Upon approval of this motion, Choose Energy understands that this component in the PUCO Community account will be unlocked. Choose Energy will then proceed to amend and resubmit the 2020 Annual Report related to its Certificate No. 12-588E through the Commission’s PUCO Community.

WHEREFORE, Choose Energy respectfully requests that the Commission grant its motion and allow it to amend its Annual Report for Fiscal Assessment for calendar year 2020 related to its Certificate No. 12-588E.
