#### Re: TracFone Wireless, Inc. - Notice of Acquisition of TracFone by Verizon Case Number 10-0614-TP-UNC

Dear Madam/Sir:

Verizon Communications, Inc. ("Verizon") and TracFone Wireless, Inc. ("TracFone") hereby notify the Public Service Commission of Ohio of the acquisition of TracFone by Verizon from América Móvil, S.A.B. de C.V. ("América Móvil"). The Federal Communications Commission approved the transfer of control on November 22, 2021 ("FCC Order")<sup>1</sup>, and the transaction closed shortly thereafter. TracFone, formerly an indirect, wholly-owned subsidiary of América Móvil, is now a direct wholly-owned subsidiary of Verizon.

There is no change in TracFone's contacts or contact information at this time. Because there will not be any immediate change in TracFone's operations, customer notice per Ohio Administrative Code 4901:1-6-29(D) is not necessary at this time. In the event any changes do take place in the future that are "not transparent to [TracFone's] customers and may impact service" customers will be notified in accordance with rule 4901:1-6-07 of the Administrative Code.

There will be no loss or reduction in service for TracFone's customers and TracFone is not amending its existing rates, terms, and conditions of Lifeline offerings at this time. In fact, the transaction will benefit underserved consumers in Ohio and nationwide because it allows Verizon and TracFone to better serve customers in the wireless prepaid segment. Consistent with the FCC Order, Verizon will maintain TracFone's Eligible Telecommunications Carrier ("ETC") status and will continue to offer Lifeline service through TracFone for at least seven years over the same service area. TracFone will also continue to operate consistent with the applicable PUCO Orders in Case No. 10-0614-TP-UNC.

While the majority of TracFone customers are currently on Verizon's network, Verizon will maintain TracFone's existing MVNO agreements if necessary to serve customers outside our network coverage for at least three years. Additionally, over that same period and before any TracFone Lifeline customer is required to transition to Verizon's network, Verizon will offer at no cost a

compatible device with comparable functionality and/or SIM replacement to that customer if the customer's existing device is not compatible with the Verizon network. These commitments, and others detailed in the FCC Order, have been put in place to ensure the acquisition is in the public interest.
