**STATEMENT OF DUKE ENERGY OHIO, INC.,  
REGARDING OUTSTANDING ISSUES**

---

On April 23, 2021, Duke Energy Ohio, Inc., (Duke Energy Ohio or Company) filed an application in the above-captioned proceedings, asking for approval to adjust its Capital Expenditure Program Rider (Rider CEP). A procedural schedule was issued by Attorney Examiner Entry, dated October 25, 2021 (Entry), establishing November 8, 2021, as the deadline for comments and intervention. On November 19, 2021, Duke Energy Ohio filed an unopposed motion to modify the procedural schedule and on November 22, 2021, the motion was granted, ordering the statement informing the Public Utilities Commission of Ohio (Commission) whether all issues raised in parties' comments have been resolved would now be due on December 10, 2021. The Company hereby files such statement.

On November 8, 2021, intervenors in the proceeding and Staff of the Commission (Staff) filed their comments and recommendations. None of such issues have been resolved. Because issues remain to be resolved and no stipulation has been reached, the Company believes that a hearing in this case is necessary under the instructions of the Entry. There is no need to expedite the hearing process.
