MEMORANDUM IN SUPPORT

By Entry of April 7, 2021, this case involves an audit of the Distribution Modernization Rider of the Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company (collectively, the Companies). On June 2, 2021, the Public Utilities Commission of Ohio (Commission) selected Daymark Energy Advisors, Inc. (Daymark or Auditor) to conduct the audit services necessary to assist the Commission with the audit. The Entry, pursuant to paragraph 14, incorporated the terms and the conditions of the Request for Proposal (RFP) into the contract between FirstEnergy and Daymark.

On October 14, 2021 Staff filed a Motion seeking an extension of the original due date of the Audit Report. Pursuant to the October 22, 2021 Entry, the draft audit report was due to Staff on December 2, 2021 and the final audit report is to be filed by December 16, 2021. However, FirstEnergy failed to timely respond to important data requests issued by Daymark. Because FirstEnergy did not submit its final data responses to Daymark until December 1, 2021, Staff received the draft Audit Report from Daymark on December 12, 2021, and is now just beginning its review. Consequently, Staff will not have enough time to review the report, discuss the report with Daymark, and still allow time for FirstEnergy to review for confidentiality and trade secret information before the December 16, 2021, deadline. Additionally, Daymark has informed Staff that its offices

are closed for the holidays from December 23, 2021, to January 3, 2022. Staff therefore requests an extension to file the Audit Report until January 14, 2022.

Ohio Adm. Code 4901-1-12(C) allows the Commission to consider a motion on an expedited basis. Inasmuch as the current deadline for the Draft Audit Report is two days away, Staff respectfully requests an expedited ruling that the deadline be extended as requested in this motion. Counsel has contacted all parties to ascertain whether any party has an objection to consideration of this motion on an expedited basis. Although responses have not been received from all parties, to date no party that has responded has expressed any objection to the extension or to an expedited ruling.
