Applicant's broker services are unlike most broker services in that it provides a robust multisupplier online informational and enrollment platform upon which commercial and industrial customers currently get information from electric and natural gas suppliers about these suppliers' service offerings. After reviewing one or more supplier's service offerings, if the customer finds a suitable offering and choose to enroll, the customer would choose the supplier of their choice and can enroll for service using the chosen supplier's electronic enrollment process, or other contractual process and paperwork directly with the supplier.

Applicant's sales model is passive as the customers come to Applicant's website, usually through discovery via an internet search. As a result, Applicant does not approach customers and does not conduct door-to-door in person marketing, or engage in calling prospective customers, and the decision to enter the website belongs to the customers.
