Now comes the Board of County Commissioners of Hancock County, Ohio, by and through counsel, and hereby moves to intervene in this proceeding pursuant to Section 4906.08 of the Ohio Revised Code and Section 4906-2-12 of the Ohio Administrative Code, and states as follows:

1. That it is the body of duly elected officials authorized to act for Hancock County, Ohio, and has authorized intervention in this proceeding;
2. That the entirety of the proposed facility is to be located in Hancock County, Ohio, and therefore in the jurisdiction of the Board of County Commissioners of Hancock County, Ohio;

3. That it desires to intervene in the proceeding on the grounds that it has an extensive interest in the proceeding as the elected representatives of the citizens of Hancock County, Ohio; that said County's interest is not and cannot be represented by another party, existing or otherwise; that its contribution of presenting to the Ohio Power Siting Board the costs and benefits of the project to the citizens of Hancock County is essential to a just and expeditious resolution of the

issues involved in the proceeding; and that it would not unduly delay the proceeding or unjustly prejudice an existing party.
