On September 30, 2021, Vectren Energy Delivery of Ohio, Inc. d/b/a CenterPoint Energy Ohio (CEOH) filed its Application to revise its Tax Savings Credit Rider ("TSCR") in Case No. 21-1020-GA-RDR. In accordance with the Stipulation in Case No. 19-29-GA-ATA approved and adopted by the Commission on July 1, 2020; proposed rates will become effective on the January 1st of the following year, unless suspended at the recommendation of Staff, by the Commission on its own initiative, or following a recommendation by an intervening party, through an entry or decision of the Commission issued in the proceeding. On November 12, 2021, Staff filed its Review and Recommendation finding the proposed tariff complies with the Commission Order. Please find enclosed a copy of Second Revised Sheet No. 33. The updated tariff sheet is effective January 1, 2022. Please update accordingly the Commission's copy of CEOH's tariffs.

APPLICABILITY

The Tax Savings Credit Rider ("TSCR") is applicable to any Customer served under the Rate Schedules identified below.

- Rate 310 Residential Default Sales Service
- Rate 311 Residential Standard Choice Offer Service
- Rate 315 Residential Transportation Service
- Rate 320 General Default Sales Service
- Rate 321 General Standard Choice Offer Service
- Rate 325 General Transportation Service
- Rate 345 Large General Transportation Service
- Rate 360 Large Volume Transportation Service

DESCRIPTION

The Tax Savings Credit Rider will flow back the tax benefits realized under the Tax Cuts and Jobs Act of 2017 in accordance with guidelines of Commission Orders.

RECONCILIATION

The TSCR is subject to reconciliation or adjustment annually, including but not limited to, increases or refunds. Such reconciliation or adjustment shall be limited to: (1) the twelvemonth period of expenditures upon which the rates were calculated, if determined to be unlawful, unreasonable, or imprudent by the Commission in the docket those rates were approved or the Supreme Court of Ohio; (2) the Commission's orders in Case No. 18-47-AU-COI or any case ordered by the Commission to address tax reform changes.
