**MOTION OF CELLCO PARTNERSHIP d/b/a VERIZON WIRELESS SERVICES, LLC  
TO AMEND ITS ANNUAL REPORT FOR CALENDAR YEAR 2020**

Cellco Partnership d/b/a/ Verizon Wireless Services, LLC (“Verizon”) is authorized to provide competitive telecommunication services throughout the state of Ohio pursuant to Certificate No. 90-5444, which was issued by the Public Utilities Commission of Ohio (“Commission”) effective June 11, 2001, in Case No. 01-1124-CT-ACE.

Pursuant to the Commission's entries issued on June 11, 2001, Verizon filed its annual report for fiscal assessment for calendar year 2020 on April 30, 2021 (the "Annual Report"). However, the reportable Intrastate Gross Revenue amounts incorrectly included Internet Services Revenue which resulted in an overpayment of \$1,377,909.94. Accordingly, by this Motion, Verizon requests leave to amend its 2020 annual report to list the correct revenue amounts identified below for the following entities covered by the report:
