On November 30, 2021, in the above-captioned proceeding, The East Ohio Gas Company d/b/a Dominion Energy Ohio (DEO) filed an application for approval of an alternative rate plan.

On December 30, 2021, in accordance with Ohio Adm.Code 4901:1-19-07(A)(1), Staff filed a letter in this proceeding finding DEO's application to be in substantial compliance with Ohio Adm.Code 4901:1-19-06. The Staff letter specifically noted that DEO's application "did not include the verification by the president or a vice-president and the secretary or treasurer of the applicant, as required under R.C. 4909.18, and therefore recommends that the Company file these verifications." (Staff Letter (Dec. 30, 2021) at 1.)

Ohio Adm.Code 4901:1-19-07(A)(3) provides, "If the application is in substantial compliance, the applicant shall file its response to the commission staff's letter within fifteen calendar days. If the applicant's response places the application in technical compliance, the application shall be considered as having been filed as of the date the original application was filed." Please find included herein the verifications required by the Staff letter. With this submission, DEO's application should be deemed in technical compliance under Staff's recommendation in accordance with Ohio Adm.Code 4901:1-19-06.
