In accordance with Ohio Admin. Code 4901:1-24-11, governing Retail Electric Service Provider Certification requirements and Ohio Admin. Code 4901:1-27-11 governing Competitive Retail Natural Gas Broker Certification requirements, EnerConnex, LLC (“EnerConnex”) hereby notifies the Public Utilities Commission of Ohio (“Commission”) that EnerConnex, a wholly-owned subsidiary of SJI Energy Investments, LLC and Applied Energy Partners, LLC, a wholly-owned subsidiary of SJI Energy Investments, LLC have merged effective December 31, 2021 at 11:59 p.m. EnerConnex, LLC will be the surviving entity. There are no material changes to EnerConnex’s CRES and CNGS licenses in connection with this merger. EnerConnex has assumed responsibility for all of the AEP assets and liabilities.

All customers and Suppliers (CRES) with whom AEP conducts business in Ohio are being notified in writing the required ninety days prior to the switch.
