**FIRSTENERGY CORP. AND FIRSTENERGY SERVICE COMPANY'S NOTICE  
REGARDING MARYLAND PUBLIC SERVICE COMMISSION PROCEEDING**

---

At the prehearing conference held on January 14 in Case No. 20-1629-EL-RDR, the Attorney Examiners requested that any updates regarding the Maryland Public Service Commission ("Maryland Commission") decision related to FirstEnergy Corp.'s internal investigation report be filed on the dockets of Case Nos. 17-974-EL-UNC and 20-1629-EL-RDR.

On January 25, the Office of the Ohio Consumer's Counsel ("OCC") filed a Notice of Decision, attaching the Maryland Commission's January 6 Order on Appeal. *See* Case No. 17-974-EL-UNC, Notice of Decision (Jan. 25, 2022) ("Notice"). OCC also stated in its Notice that the Maryland "Order on Appeal is now subject to reconsideration." *Id.* This is to advise the Examiners that at a virtual status conference held on January 19, the Maryland Commission denied a request for partial reconsideration that had been filed by the Maryland Office of People's Counsel on January 13, 2022. *See* Case No. 9667 Status Conference, at 24:30 (Md. PSC Jan. 19, 2022), available at <https://www.youtube.com/watch?v=Ht5hIY1eIU8>. The Maryland Commission also called for written comments from the parties, including comments on the issue of whether further proceedings are necessary. *Id.*
