**MOTION FOR EXTENSION**

---

Pursuant to Ohio Administrative Code Rule 4901:1-27-09(B) and 4901:1-27-07, Chrislynn Energy Services, Inc., (“Chrislynn”) seeks an extension of Certificate 14-343G (4), which was issued in Case No. 14-0101-GA-AGG with an expiration date of February 16, 2022. Due to issues related to securing a credit report to satisfy renewal application requirement C-5, Chrislynn was not able to file its renewal application within the sixty to thirty days prior to expiration date of its certificate. Chrislynn is filing this instant Motion to request extension of its current certificate pursuant to Ohio Adm. Code 4901:1-27-09(B) to ensure that its certificate does not lapse while the Commission reviews its renewal certificate that has been filed contemporaneously with this Motion. This Motion is being filed prior to the February 16, 2022 expiration date of Chrislynn’s certificate.

Chrislynn respectfully requests that Certificate No. 14-343G (4) be automatically extended from February 16, 2022, until the date that the new certificate is issued in Case No. 14-0101-GA-AGG, pursuant to Ohio Adm. Code 4901:1-27-09(B).

**MEMORANDUM IN SUPPORT OF

Chrislynn is filing this motion pursuant to O.A.C. 4901:1-27-09(B) to request that Certificate 14-343G (4) be automatically extended during the pendency of the application review in Case No. 14-0101-GA-AGG so that Chrislynn can continue serving its customers.

Ohio Administrative Code Rule 4901:1-27-09(B) provides that a motion requesting an extension of a certificate will be deemed automatically approved if filed in conformance with 4901:1-27-07 unless ruled otherwise by the Commission or an Attorney Examiner within three business days. Chrislynn submits that it has met the criteria and respectfully requests an automatic extension of the expiration date of Certificate No. 14-343G (4) issued in Case No. 14-0101-GA-AGG until such time as a new certificate is issued in Case No. 14-0101-GA-AGG.
