MEMORANDUM IN SUPPORT OF JOINT MOTION TO CONTINUE DEADLINES AND REQUEST FOR EXPEDITED RULING

Dodson Creek Solar, LLC ("Applicant"), Robert and Laurie Banks, and the Ohio Farm Bureau Federation (collectively referred to as the "Parties"), respectfully request that the February 14, 2022 deadline to file a stipulation and Applicant testimony in support of the stipulation and the February 18, 2022 deadline for Ohio Power Siting Board Staff ("Staff") and intervenors to file their expert and factual testimony, established in the January 26, 2022 Entry, be suspended. Additionally, the Parties also request that the February 24, 2022 evidentiary hearing be converted into a status conference. The Parties intend to provide the Administrative Law Judge ("ALJ") during the status conference with potential dates for a revised procedural schedule and an update on how settlement discussions are proceeding.

As the ALJ is aware, the parties in this proceeding continue to be engaged in discussions regarding a possible stipulation in this proceeding. The ALJ previously granted a second extension via the January 26, 2022 Entry; however settlement discussions are still ongoing. To allow time for continued negotiation, the Parties request that the ALJ suspend the procedural schedule in this proceeding. The Parties will work towards identifying specific dates for the evidentiary hearing, the filing of a potential stipulation and Applicant testimony in support of the stipulation, and Staff and intervenor testimony as they negotiate, and will inform the ALJ of these dates during the February 24, 2022 status conference.

Accordingly, there is good cause for continuing the hearing and suspending the deadlines for the various procedural dates identified above. The parties continue to be engaged in settlement discussions regarding certain issues and conditions presented in the Staff Report of Investigation, and continuing the hearing and suspending related procedural deadlines will allow the parties to

not only continue their settlement discussions, but also, to the extent a settlement is reached, to address the settlement in their filed testimony.

Prior to the filing of this Motion, the Applicant contacted the other parties in this proceeding, and no party opposes the Motion. Additionally, while Staff, the Board of Trustees for Dodson Township, and the Board of Trustees for Hamer Township are not signatory parties to this Motion, the Applicant has confirmed that none object to this continuance request. No party objects to an expedited ruling on the Motion, given the current stipulation (and any testimony supporting the stipulation) filing date of February 14, 2022. Thus, good cause exists to grant the Motion and to do so on an expedited basis.

WHEREFORE, for the above reasons, the Parties request that the ALJ grant the Motion to extend the deadlines as identified above and continue the evidentiary hearing.
