On May 3, 2021, as supplemented, the Applicant filed an application with the Ohio Power Siting Board ("Board") proposing to construct a wind-powered electric generation facility in Paulding County, Ohio.

The Staff of the OPSB filed its Staff Report of Investigation ("Staff Report") on January 24, 2022. By entry issued November 10, 2021, the Board established the procedural schedule in this matter and directed parties to file, by February 16, 2022, their list of issues about which they may be interested in pursuing cross-examination of witnesses at the evidentiary hearing. Upon review of the Staff Report, the Applicant notes that it may be interested in discussion and clarification regarding Staff Report Conditions 1, 2, 8-10, 23, 25-26, and 39.

The Applicant, by providing this list, is not waiving its right to address other issues and reserves its right to include additional issues upon cross-examination.
